Agendas and Decisions:

- Web Designer: Secretary Parashu Timalsina introduced web designer Shushan Manandhar to the meeting and proposed for designer for the NECC. Meeting approved the proposal and requested Mr. Manandhar to work with Suvash Khatiwada to make the website more effective and vibrant.
- 2. NECC Guideline: Vice President Saroj Prajapati, Vice President Lok Tiwari, General Secretary Netra Ghising, Secretary Parashu Timalsina, Property Manager Krishna Prajapati, and President Khilendra Neupane prepared a brochure, primary responsibilities of pundit-ji, and rules/regulations (rental guideline) for the mandir/community hall and provided entire team members to review before the meeting. Meeting discussed in-detail and approved all three documents with regards to improve the service delivery and manage the NECC operation and day to day work efficiently and effectively.
- 3. **Nepali Mela during the Durga Puja:** Vice President Ram Chandra Kharel proposed to organize Nepali Mela during the Durga Puja every year. Right before the great festival of Dashain, "The Mela" will create more festive mood in the community and meeting agreed his proposal and delegated him for planning.

- 4. Access of another Toilet: President Khilendra Neupane proposed to open another access door of the toilet that pundit-ji is using currently. During the meeting attendees reviewed the spot and approved the proposal and delegated Vice President Umesh Niroula to manage this task with contractor by April 14, 2018. Meeting also decided that this door will only access to the visitor when it needs. VP Mr. Niroula informed to the meeting that Engineering team is preparing all the required documents from the County to build another two toilets next to the meeting room as planned.
- 5. Responsibilities of Finance: Treasurer Laxman Pradhan informed to the meeting that he has prepared "Expense Reimbursement Form" and "Revenue Categories Form" for expense reimbursement and bank deposits to make more financial records systematic. He further mentioned that categorize revenue into different buckets can easily differentiate the categories of revenue for reporting purposes. It also helps us issuing an acknowledgment letter for the donation. He requested the committee members to complete the revenue items sheet. This will help us in reconciling the books. We can determine the totals by considering bank transactions but cannot categorize the revenue. Per Mr. Pradhan's recommendation, Meeting assigned the following responsibilities:
 - Vice Treasurer Pancha Shrestha will handle the accounts receivable and keep a record of dollar-a-day donors and follow up to collect outstanding balances. He will also send an acknowledgment letter to all donors.
 - Vice Treasurer Ram Chandra Bhattarai will handle the accounts payable. He
 will review and record all receipts before approving the expense
 reimbursements. Everyone needs to complete the Expense Reimbursement
 Form and submit them to him.
 - Secretary Madhu Bhandari will keep the membership records such as dollara-day, life members and trustees. Please send all copies to checks and bank deposit slips to him for record keepings.
 - Treasurer Laxan Pradhan will be responsible for entire financial activities and will issue the financial report in quarterly basis. He will handle the online payments, credit cards, paypal, etc. merchant account to Capital One Bank for the NECC.

Today, total \$1,000.01 was counted from pundit-ji and donation box and Vice Treasurer Ram Chandra Bhattarai deposited to the bank. Another Vice Treasurer Panch Shrestha informed to the meeting that he sent donation receipts to the donors and following up for the pledged donors as well. NECC Treasurer Laxman Pradhan informed to the meeting that County approved property tax exemption for the NECC. Treasurers' team prepared the Trustees and Dollar-A- Day donors' list to publish in
